This year, #AIROPS20 will also present an exclusive evening of <u>Belgium Delights and Aviation</u>. Belgium has a well-deserved reputation for culinary and brewing excellence, but perhaps less known is its storied aviation heritage. Hosted by some of Belgium's leading business aviation companies, this inspiring evening of discovery will showcase the Belgian aviation tradition along with an appetizing spread of local and craft beer delights.
